## RoHS Exemption Reference

*6(a)-I. Lead as an alloying element in steel for machining purposes containing up to 0.35 percent lead by weight and in batch hot dip galvanized steel components containing up to 0.2 percent lead by weight* 

6(b)-1. Lead as an alloying element in aluminium containing up to 0,4 % lead by weight, provided it stems from lead-bearing aluminium scrap recycling

6(b)-II. Lead as an alloying element in aluminium for machining purposes with a lead content up to 0,4 % by weight

*6(c). Copper alloy containing up to 4% lead by weight.* 

7(a). Lead in high melting temperature type solders (i.e. lead-based alloys containing 85 % by weight or more lead).

7(c)-I. Electrical and electronic components containing lead in a glass or ceramic other than dielectric ceramic in capacitors, e.g. piezoelectronic devices, or in a glass or ceramic matrix compound.

*7(c)-II. Lead in dielectric ceramic in capacitors for a rated voltage of 125 V AC or 250 V DC or higher.* 

8(b)-I. Cadmium and its compounds in electrical contacts used in

- circuit breakers;

- thermal sensing controls;

- thermal motor protectors (excluding hermetic thermal motor protectors

- AC switches rated at 6 A and more at 250 V AC and more, or 12 A and more at 125 V AC and more

- DC switches rated at 20 A and more at 18 V DC and more, and

- Switches for use at voltage supply frequency  $\geq$  200 Hz

15(a). Lead (Pb) in solders to complete a viable electrical connection between the semiconductor die and carrier within integrated circuit flip chip packages where at least one of the following criteria applies:

- a semiconductor technology node of 90 nm or larger;

- a single die of 300 mm2 or larger in any semiconductor technology node;

- stacked die packages with die of 300 mm2 or larger, or silicon interposers of 300 mm2 or larger.
